TE 22/05/133 Review of Benches Policy-

It was proposed that the benches should all be reviewed and restored where possible and the installation of the 3 new ones immediately:

- Beryls on the Burgage
- Froggatts
- WMG

Cllr Karen Roberts proposed that once we are on top of the ones we can do now we will then look to review them Halam Road/Hopkiln Lane must be a priority.

It was also proposed that the bench at the top of Nottingham Rd to be moved 10m down the bank, away from the tree also the Lowes Wong bench into a more appropriate location.

Proposal for the purchase of Festive Lights- previously circulated

It was agreed that there had been some miscommunication in what is being proposed to illuminate the Burgage, the proposal is to "up light" the trees and not to "light the branches."

It was unanimously agreed that further work needed to be carried out To establish what works needed to go into the illumination of the Burgage. Also need to consider if this would be a permanent installation or temporary light solution. Cllr Stuart Thompstone agreed he would investigate this further.

There was a unanimous decision to extend the lease to the existing loom and the money was budgeted for.

It was unanimously agreed that the lighting of the market Square can be explored further but this was unfunded and would need to go to G&F.
